1.1 General

The contractor shall collect garbage from each residence and State warehouse Comp. twice per week, and from the Embassy compound three times per week according to the schedule provided by COR.

The contractor will provide two laborers and one driver with each truck to pick-up the garbage. The laborers will pick-up the trashcans from the specified sites and dump their contents into the truck. They will sweep-up any debris and sign on the pickup control sheet.

The contractor shall dump in an approved landfill and provide the monthly paid receipt with his monthly invoice to the Embassy.

1.3 Submittals

1.3.1 The contractor shall submit as part of his bid, the following:

1. Preliminary work schedule.
2. Safety plan according to the SAFETY AND HEALTH REQUIREMENTS of the US Army Corps of Engineers, which will be reviewed and approved by the POSHO

1.3.2 After contract award the contractor shall submit the following

1. A work schedule by working days on each job.

1.4 Project procedures

1.4.1 All work shall be performed early in the morning from 07:00 a.m. to 5:00 p.m., Monday through Friday (Saturday on exceptional case) except for U.S. and Local

calendar holidays, which are considered non-working days. Other hours may be approved by the COR with at least 24 hours advance written request.

1.4.2 The contractor shall load trash removal from each stated places not from the street or outside the property. Violation of this condition and results of this violation will be the complete responsibility of the contractor.

1.5 Existing Conditions

1.5.1 Before beginning the work, investigate and verify the existence and location of other systems affecting the Work.

1.5.2 The submission of the bid will be conclusive evidence that the bidder has complied with all conditions related to the character and quantity of work requirements to be performed. No claims for additional time or compensation due to variations between existing and conditions encountered during the work will be honored. Failure of the contractor to thoroughly inspect and identify defects, if any, shall not release him from the responsibility to guarantee the whole works (Existing to remain, and new works) for the period specified in the contract terms.

1.6 Protection of installed construction

The contractor shall provide final protection and maintain conditions that ensure installed work is without damage or deterioration at time of substantial completion.

1.7 Schedule

The contractor shall submit detailed schedule showing each activity along with its duration, predecessors, and successors.

1.8 Security Procedures – GSO or Security personnel details

All the contractor's personnel shall be subject to all the security procedures required by U.S. Embassy.

These requirements shall include:

1.8.1 Contractor shall provide a list of all employees who will need to have access to the sites. The contractor will provide this list at least two weeks in advance of work commencing.

1.8.2 All contractor personnel shall be subject to a daily check (in and out) by the house guard personnel and escorted by assigned person from Facility when it's in the Embassy compound and State warehouse compound.

1.9 Safety regulations

All the contractor personals shall be subject to comply with the safety procedures implemented by the SAFETY AND HEALTH REQUIREMENTS of the US Army Corps of Engineers.

**QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. **SURVEILLANCE.** The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
  
2. **STANDARD.** The performance standard is that the Government receives no more than one (1) [Note to Contracting Officer: Insert other number if desired] customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
  
3. **PROCEDURES.**
  - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
  - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.



(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]

- (4) Any estate (other than a foreign estate, within the meaning of [26 U.S.C. 7701\(a\)\(31\)](#)); and
- (5) Any trust if-
  - (i) A court within the United States is able to exercise primary supervision over the administration of the trust; and
  - (ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) This clause applies only to foreign persons. It implements [26 U.S.C. 5000C](#) and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c)

(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. 52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

*Foreign person* means any person other than a United States person.

*Specified Federal procurement payment* means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

*United States person* as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS.
